**IN EXERCISE** of the powers conferred by section of 223 of the Mining Act, 2016, the Cabinet Secretary for Mining, Blue Economy and Maritime Affairs, makes the following Regulations—

# THE MINING (MINE SUPPORT SERVICES) (AMENDMENT) REGULATIONS, 2023

Citation.

1. These Regulations may be cited as the Mining (Mine Support Services) (Amendment) Regulations, 2023.

- The Mining (Mine Support Services) Regulations, 2017 in these Regulations referred to as the "principal Regulations" is amended in regulation 4—
  - (a) by inserting the word "First" immediately after the words "by completing Form MS1 in the" in sub-regulation (2);
  - (b) in sub-regulation (3)
    - i. by deleting the word "prescribed"; and
    - ii. by inserting the following words "the fee specified in the Second Schedule" immediately after the words "upon payment of".
  - **3.** Regulation 6 (1) of the principal Regulations is amended by inserting the following new sub-regulation (1)—

**1A.** The issuance of the licence under sub-regulation (1) shall be upon payment of an annual fee as specified in the Second Schedule.
